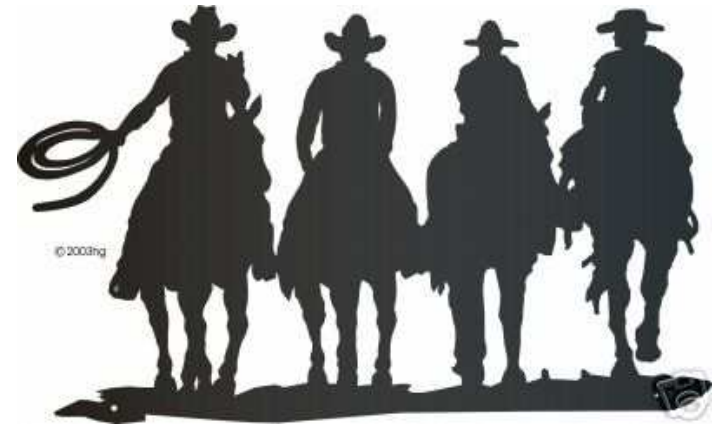
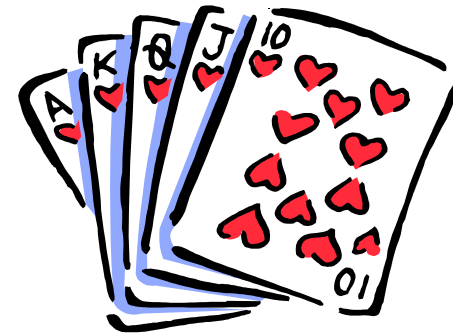

**Directions to the Poker Ride:**

From Points North & South: Use Hwy 101 to Hwy 246 West. Go about 6 miles west of Buellton to Drum Canyon Rd (opposite Mail Rd.). Turn **RIGHT**, go 2 miles, then turn **RIGHT** at arena onto dirt road & continue 1 mile (keep to right on road) to staging area. Follow ribbons & signs.

From Lompoc: East on Hwy 246 about 11 miles, left on Drum Canyon Rd. (opposite Mail Rd). Turn **LEFT**, go 2 miles, then turn **RIGHT** at arena onto dirt road & continue 1 mile (keep to right on road) to staging area. Follow ribbons & signs.

CHECK-IN time will start at 8:30 a.m., first group of riders out at about 9:30 a.m. ALL riders must register upon arrival. At that time you will receive your packet: with your number, 2 raffle tickets, BBQ ticket, and the first card deal of your hand. Additional raffle tickets 50¢ each. Additional hands \$10 Sr./\$5. Jr.

This ride is designed with novice and children in mind, and will be a easy, casual & leisurely ride. **No long trotting or loping permitted!**

Length of the ride will be about 2 hours. Trail will be marked. Riders will form groups with a leader. All riders shall be out on the trail by 11:00 a.m. Cost as follows:

LVR Adult Member (18 & Over)	\$25	Non-Member Adult	\$30
LVR Youth Member (17 & Under)	\$20	Non-Member Youth	\$25

**You will be receiving 7 cards and forming your 5-card best hand**

No alcoholic beverages permitted on the trail and **NO SMOKING**, except in your own vehicle. All riders must wear boots/shoes with a well-defined heel. **Minors (17 & under) are required to wear an ASTM/SEI approved equestrian helmet.** Required tack: headstall with snaffle, curb, mechanical hackamore or bosal; any style saddle that fits horse & rider.

**NO STALLIONS PERMITTED • NO DOGS PERMITTED**

Riders 12 & under **MUST** be accompanied by an adult (18 & over). All children must be supervised by an adult while on the premises.

Tri-tip barbecue will be served at the end of the ride (approx. 1:00 p.m.) If you wish to purchase additional dinners, the charge will be \$10.00 for adults, and \$5.00 for children under 12. Sodas will be available for 50¢ each, but bring your own drinking water. Please bring your own lawn chairs.

After the awards, there will be a drawing for many different prizes, both horse-oriented and not. You will be able to purchase additional tickets for 50¢ each. Everyone is invited to participate.

**WAIVER & RELEASE OF LIABILITY**

**EACH PERSON MUST SIGN THE RELEASE FORM: PARENT/GUARDIAN MUST SIGN FOR MINOR**

**I acknowledge that horseback riding is a sport, which carries inherent risks of injury and damage to myself, my horse, and property. I knowingly assume all risks, whether known or unknown, of horseback riding.**

I hereby release the Lompoc Valley Riders, hereinafter referred to as "LVR" and Rob Guerra Ranch, Red Willow Ranch & Bill Jerrard Ranch, hereinafter referred to as "The Ranch(s)" from all liability for any act of negligence or want of ordinary care on the part of the LVR and/or The Ranch(s), and any of its agents.

In consideration of my participation in events organized or sponsored by LVR, I waive, release, and discharge LVR and The Ranch(s), their directors, officers, agents, and members, their representatives, heirs, executors, and assigns from any and all claims of liability for injury or damage to myself, my animals, or my property arising out of my participation. This agreement is binding upon my executors, heirs, and assigns.

**I expressly waive any rights I may have under California Civil Code 1542, which states:** "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him might have materially affected his settlement with the debtor."

I agree that I will indemnify and hold harmless LVR and The Ranch(s), their officers, directors, members, and agents against all claims, demands, and causes of action, including court costs, and actual attorney fees, arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

LVR and The Ranch(s), its agents or employees shall not be liable for any damage which may accrue from any cause or as a result of fire, theft, running away, state of health, injury to person, horse, or property

**I acknowledge that I must be financially responsible for having my own accident insurance to cover the inherent risks of injury to myself or my horse or any damages to my property that is associated with horseback riding and related activities.**
